

CORRIGENDUM **to the Application pack of the 1st Open Call for Proposals in the frame of the** **Operational Programme Slovenia-Austria 2007-2013 published on 18 July 2008**

Pursuant to point 15 (Amendments to the Open Call for Proposals) of the 1st Open Call for Proposals in the frame of the Operational Programme Slovenia-Austria 2007-2013, the original wording of the Application Pack documents has been changed in Slovenian, German and English version as stated in the following text. The applicants are obliged to consider the amendments published on the following website only: www.si-at.eu.

English version of the Application Pack documents has been changed as follows:

GUIDE FOR APPLICANTS

Title page: wording »Version no.1« is replaced by »Version no. 2« and the date »18 July 2008« changes to »19 September 2008«.

Section 3.3 Project size, financing and project duration: the wording of the fourth paragraph “Financing” »... on the basis of the public open call...« is deleted.

Section 3.6 Revenues: the wording in the first indent of the third paragraph “... eligible expenditures.” is replaced by “...total expenditures”. The same applies to the next indent, where these words are repeated.

Section 4.4.1 Personnel expenditure, a) Labour expenditure of Lead Partner /Project Partner (LP/PP) employees working on a project: the wording of the fifth paragraph “... only partly...” is deleted.

Section 4.4.3 Investments, b) Construction works: the wording of the second paragraph “ ... together with the application” is replaced by “... prior to signing of the contract”

Section 4.4.4 Administrative expenditure (overheads): the wording of the first indent of the third paragraph “... 7% of total eligible costs,” is replaced by “... 7% of total direct eligible costs,”. The same applies to the next indent, where these words are repeated.

Section 4.4.4 Administrative expenditure (overheads): the wording of the fifth paragraph “... is 25% of total eligible expenditure” is replaced by “... is 25% of total direct eligible expenditure”.

Section 5.1 Project development: the wording in the ninth indent “... public national/regional co-financing of the eligible project costs...” is replaced by “... the other public funding within the total public funding...”

Section 6.1 Basic information: the sentence in the second paragraph “the forms are in a bilingual format and have to be prepared in **Slovene and German language.**« is supplemented by »except Annex 5 which can be submitted in a single language only.«.



Section 6.2.6 Expected Project Costs and

Financing: the fourth paragraph “The amounts excluding VAT should be inserted for each partner in the columns 1 to 4.” is replaced by “The whole table shall be filled in according to the VAT status. If the VAT can be totally recovered, then “YES” shall be inserted in the column 5 and the amounts deducted by the VAT shall be inserted into the table. If the VAT cannot be recovered, then “NO” shall be inserted in the column 5 and the amounts inclusive VAT shall be inserted into the table. If the VAT can be only partially recovered, then the percent of the recoverable VAT is to be inserted in column 5, and the amounts inserted shall include the VAT amount which is to be refunded by the project co-financing”

Section 6.2.6 Expected Project Costs and Financing: the wording in the second point of the seventh paragraph “2. *Own contribution* is the amount of project co-financing ensured by project partners from national, regional, local and other sources of financing” is to be replaced by “2. *Own contribution* is the sum of the following amounts:

- co-financing amounts of the project which are granted to the project partner by the co-financing bodies (e.g. national or regional sources) and
- amount of the own co-financing of the project, which is provided by the project partners themselves from their own funds (public or private funds)”

Section 6.2.6 Expected Project Costs and Financing: the wording of the seventh paragraph, point 3. Total “... column 8, *Total eligible costs* deducted by column 7, *Revenues*.” is replaced by “... column 8 (Total eligible costs), which is column 6 (Total costs) deducted by column 7 (Revenues) - not relevant in State aid cases”.

Section 6.2.9 Annexes, Annex 3 - Lead Partner Statement: the wording in the second paragraph “... by the Lead partner as his own contribution.” is replaced by “... by the Lead partner’s own funds (own co-funding).”

Section 6.2.9 Annexes, Annex 3 - Lead Partner Statement: last paragraph “**Check:** the amount has to equal the amount stated in the Annex 1 – Budget and the amount of own contribution of the Lead Partner inserted in the table 6.2.1 of the Application Form.” is deleted.

Section 6.2.9 Annexes, Annex 4 - Partnership Statement: the wording of the second paragraph “... by the project partner as his own contribution.” is replaced by “... by the project partner’s own funds (own co-funding).”

Section 6.2.9 Annexes, Annex 4 - Partnership Statement: the last paragraph “**Check:** the amount has to equal the amount stated in the Annex 1 – Budget and the amount of own contribution of the Project Partner inserted in the table 6.2.1 of the Application Form.” is deleted.

Section 6.2.9 Annexes, Annex 5 - Co-financing Statement: the wording “The Co-financing Statement is issued by the funding body for each individual project partner.” is supplemented by “ in a single language on the provided or any other form containing all of the following data:

- acronym
- name of the project partner



- name of the co-financing institution
- maximum amount of the public co-financing
- name of the signatory and the signature.”

Section 6.2.9 Annexes, Annex 5 - Co-financing statement: the wording in the second paragraph “automatically” is deleted, so the sentence reads “ In Slovenia, the national co-financing at state level will be granted if the project is approved by the Joint Monitoring Committee.”

Section 8.2 Eligibility check and selection criteria: in the table 1. Administrative and Eligibility Check, under Administrative check in point, 1 the wording “... or submitted by e-mail.” is deleted.

Section 8.2 Eligibility check and selection criteria: in the table 1. Administrative and Eligibility Check, under Budget and financing in point 9, the wording “The total eligible project costs are...” is replaced by “Requested amount of the ERDF funds is...”

Section 8.2 Eligibility check and selection criteria: in the table 1. Administrative and Eligibility Check, under Budget and financing in point 10, the wording “... 25% of the project total eligible costs” is replaced by “... 25% of the project total direct eligible costs”.

ANNEX 2: Indicators on programme, priority and project level

Point 1. Pre-defined indicators on Programme level: the wording in the rows 42, 43 and 44 »Number of projects respecting...« is replaced by » Project respects...«.

ANNEX 3: Lead Partner Statement

In the text under »Own contribution to the project budget« the wording »... as own contribution.« is replaced by » ... as own funds (own co-funding)«.

ANNEX 4: Partnership Statement

In the text under »Own contribution to the project budget« the wording »... as own contribution.« is replaced by »... as own funds (own co-funding)«.

GENERAL
